

License Agreement for Educational Use of Photogrammetry Dataset

This License Agreement ("Agreement") is made and entered into as of [DATE] by and between Eric Paré Studio Inc. / Xangle ("Licensor") and Jeffrey Ian Wilson ("Licensee").

1. Grant of License Licensor grants Licensee a limited, non-exclusive, non-transferable, and revocable license to use the photogrammetry dataset ("Dataset") solely for educational purposes in connection with the creation and distribution of an online course. This license does not permit any other use of the Dataset.

2. Restrictions Licensee agrees to the following restrictions:

2.1. The Dataset may not be used for any personal or commercial projects, including but not limited to advertising, product development, or entertainment purposes.

2.2. The Dataset may not be used to train or develop artificial intelligence (AI) models or machine learning systems.

2.3. Licensee shall not modify, alter, or create derivative works based on the Dataset without prior written consent from Licensor.

2.4. The Dataset may not be redistributed, shared, sublicensed, or otherwise made available to any third party without prior written approval from Licensor, except as part of the "3D Scanning Masterclass" created and distributed by Licensee, which is explicitly authorized under this Agreement.

3. Ownership and Attribution 3.1. Licensor retains all rights, title, and interest in and to the Dataset, including all associated intellectual property rights.

3.2. Licensee shall provide clear and visible attribution to Licensor in the online course and any related materials, as follows: "Photogrammetry Dataset provided by Eric Paré Studio Inc. / Xangle."

4. Term and Termination 4.1. This Agreement shall remain in effect unless terminated by either party.

4.2. Licensor reserves the right to terminate this Agreement immediately upon written notice if Licensee breaches any of the terms herein.

4.3. Upon termination, Licensee must immediately cease all use of the Dataset and delete any copies in their possession.

5. Limitation of Liability Licensor shall not be held liable for any damages, losses, or expenses arising out of or in connection with the use of the Dataset by Licensee.

6. Governing Law This Agreement shall be governed by and construed in accordance with the laws of Québec, Canada.

7. Entire Agreement This Agreement constitutes the entire agreement between the parties concerning the Dataset and supersedes all prior agreements or understandings, whether written or oral.

8. Amendments Any amendments or modifications to this Agreement must be made in writing and signed by both parties.
